Definitions according to Resolution 2009-146

Low demand connections are the following categories of users: nurseries, warehouses, churches, truck terminals, RV parks, RV storage yards, lumber/construction yards, public storage buildings, other facilities with offices with one or more shared restrooms, lobbies or areas whose flows are similar in volume to these listed categories.

High demand connections are the following categories of users: restaurants, supermarkets, car washes, coin laundries, shopping centers with one or more restaurants, or food court, food processing facilities, textile manufacturers, and other dischargers whose flow is similar in volume to these listed categories.

All other connections are Average Demand users, including hotels, strip malls without restaurants, office buildings, senior housing with individual living units without kitchens but with a common kitchen and other dischargers whose flow is similar in volume to these listed categories.

Quimby Act definition - Quimby Act land dedication and in-lieu fee requirements apply to parcels created by a major residential subdivision (five or more parcels). They also apply to parcels created by a minor residential subdivision (a subdivision of four parcels or less), but only if a building permit is requested within four years of the approval of the parcel map. The Quimby Act requirements do not apply to existing residential lots or to minor subdcivision that do not seek building permits within four years of receiving parcel map approval. (Sinclar & Assoc. 4-09)

As of July 1, 2009, the following fees shall be in effect as per the subject Resolutions:

Resolution No. 89-46, Section 1 (Police Impact)

- A. \$370.00 per residential dwelling unit; and
- B. \$.2195 per square foot of building floor area for commercial and *industrial uses;
- * may be deferred per Resolution No. 95-59

Resolution No. 89-47, Section 1 (Fire Impact)

- A. \$490.00 per residential dwelling unit; and
- B. \$.2926 per square foot of building floor area for commercial and *industrial uses;

B. PERMIT AND INSPECTION FEE (Minimum \$500.00 surety required on each permit)

GROUP I: Single Family Residential work within City of Hollister Right-of-Way. Includes work in easements.

Permit fee: \$163.00

Typical Work Includes:

- Single Drive Approach, new and modified
- Utility laterals for Water, Sewer, and/or Drainage
- Sidewalk installation and repair
- Curb & Gutter installation and repair with adjacent paving repair
- Parkway paving

GROUP II: Multi-Family Residential, minor Commercial improvements within City of Hollister right-of-way. Includes work in easements:

Requires a deposit to be \$620.00 to cover inspection time. Unused portion will be refunded after the project is closed out. The Minimum Permit Fee will be \$163.00

C. IMPROVEMENT PLAN CHECK AND INSPECTION.

(Surety for faithful performance and surety for Labor and material are required prior to approval of plans)

Large Development projects including Subdivisions, Commercial Projects, and other land development projects.

Requires Approved Improvement Plans and Engineers Estimate

\$0 to \$99,000	9% of cost of improvement
\$100,000 to \$499,000	8% of cost of improvement
\$500,000 and above	7% of cost of improvement
